- Created a task force (Bill McConnell, Diane Baldwin, Jerry Van Marter) to look at issues of church membership in circumstances when individuals who are not members become regular participants in virtual worship of congregations.
- Met with the Rev. Luke Choi, manager for support of Korean-speaking councils, to discuss cultural understanding of Korean Presbyterian churches in general and the Korean Presbyterian Church of Louisville in particular.

The presbytery took a brief break. The meeting resumed.

**Report from Presbyterian Historical Society**: Jerry Van Marter introduced David Staniunas, Chief Archivist, from the Presbyterian Historical Society to talk about his work. David shared with the presbytery some of the offerings from the Presbyterian Historical Society.

**Fair Maps Kentucky** -- from Harvey Browne Memorial Presbyterian Church Session: Dee Pregliasco, Harvey Browne Memorial Presbyterian Church Elder, and League of Women Voters, presented information on the Fair Maps Kentucky campaign for equitable redistricting resulting from the 2020 U.S. Census. (see attached)

There was discussion and questions from the floor about the motion, endorsed by the Coordinating Commission, to endorse the campaign.

The presbytery voted and approved the motion to endorse the Fair Maps Kentucky campaign.

**Report from Bellewood-Brooklawn**: Abby Drane reported on happenings at Bellewood and Brooklawn. She shared that the group homes are locked down with COVID since March. The residents are being schooled via Non Traditional Instruction (NTI). Bellewood and Brooklawn are collecting funds to help children celebrate Thanksgiving and Christmas. Abby reported that Bellewood and Brooklawn will not be merging the various companies of which they are a part, and the entities are continuing with their existing covenants. Abby encouraged congregations to send birthday cards to the children.

**Coordinating Commission report**: Ben Blake, chair, reported that the Coordinating Commission is working to fill the final position for the presbytery Nominations and Representation Committee. This will likely come in February.

**Finance Committee report**: Don Garton, chair, was not available on Zoom. On behalf of the Finance Committee, Ben Blake reported that the finances for the Presbytery of Mid-Kentucky continue to be good in shape. Ben thanked the Finance Committee for all their work. (see attached)

Ben also shared about the Camp Edwards Scholarship Fund. (see attached) He reported that the Coordinating Commission has created a committee of the Coordinating Commission that will review scholarship applications for that fund. The committee will be made up of four members from the historically African American congregations and one person from the Finance Committee.

**Report from the Stated Clerk** – Jerry Van Marter, Stated Clerk, introduced Dan Rift, who recently joined Mid-Kentucky Presbytery. Dan greeted the presbytery on Zoom. Jerry introduced John Mulder, who was celebrating his 50th anniversary of ordination and Honorable Retirement. John also greeted the presbytery via Zoom.

Jerry announced that the Rev. Christine Coy Fohr will be installed at the Harvey Browne Memorial Presbyterian Church on Sunday, November 22, 2020 at 3:00 p.m.

Jerry reported that there were 98 different Zoom users identified at the meeting. Jerry reminded the presbytery that the next meeting will be Saturday, February 20th at a time to be determined. The Stated Clerk thanked Louisville Presbyterian Theological Seminary and the seven folks on the leadership team for running the meeting. Jerry pointed out that Andrew Yeager Buckley was technical director for the meeting and did a fabulous job helping the presbytery to do Zoom. Jerry also gave thanks for Mundo Brew, the group that provided the music for the beginning of the meeting.

Jerry thanked all those willing to serve in leadership in the presbytery.

### Redistricting in Kentucky: Let's Build Fair Districts by a Fair Process

#### What is redistricting?

After each federal census, redistricting is the process of drawing new boundaries for congressional and state legislative districts. The next census will be done in 2020, with results released in the middle of 2021 and Kentucky redistricting likely to occur early in 2022.

### Why should Kentucky change the way districts are drawn?

A fair approach to redistricting will:

- Avoid costly lawsuits like the ones resulting from 2012 redistricting
- Make the process transparent. Past efforts were done behind closed doors and without public hearings
- Avoid blatant gerrymandering (drawing districts to give advantage to an incumbent, a party or a group)
- Assure votes have meaning: voters in 'safe districts' have little chance to have their votes count if they support opposing party candidates
- Give voters confidence in the electoral system

### How has Kentucky done redistricting in the recent past?

After each census, the Kentucky Constitution requires redistricting bills passed by the General Assembly and signed by the Governor. The bills are

usually filed and passed within a matter of days, with little opportunity for citizen participation.

#### Why are fair districts important?

The make-up of districts can make it easier or harder:

- For citizens to believe their votes can make a difference
- For voters to learn about candidates for legislative seats and debate who can best serve their communities
- For citizens to contact and influence their legislators once they take office
- For candidates from one party to compete fairly against another party for election
- For people of diverse backgrounds to elect candidates they prefer
- For various regions of a state (rural or urban, agricultural or industrial, areas experiencing economic growth and those seeing economic decline) to get their interests considered

#### What makes districts fair?

The national League of Women Voters has called for districts that are:

- Equal in population
- Compact and competitive
- Designed for effective representation of racial and linguistic minorities,

Drawn without preference to parties or incumbent office-holders

### How can Kentucky move toward a fair redistricting process?

We can urge legislators to invite public input and build confidence in the fairness of the resulting boundaries. We will ask the legislature for four primary steps:

- 1. Public opportunities for redistricting input in 2021
- 2. A later candidate filing deadline in 2022
- **3.** Commitment to create districts that are:
  - **a.** Equal in population
  - **b.** Compact and competitive
  - **c.** Drawn without preference to parties or incumbent office-holders
  - **d.** Designed for effective representation of racial and linguistic minorities
- **4.** A redistricting plan that can pass with bipartisan support and substantially more than a simple majority vote

The national League supports **independent redistricting commissions** that can define districts without needing legislative approval of the final plan. Unfortunately, creating that kind of commission would require a constitutional amendment approved by the Kentucky House and Senate and then ratified by a majority of voters in a statewide election. That may not be a workable strategy for our state in the next few years.

An **advisory redistricting commission** may be an option. An advisory commission gathers input and proposes maps that fit within rules about fair maps, but then the legislature makes the final decision.

### How can you work for a fair process that builds fair maps?

Let your legislators know that redistricting is important to you. Share messages like these:

- We want fair redistricting.
- We don't want our state gerrymandered.
- We don't want expensive court battles over redistricting.
- Hear our voices and gather our input and concerns before new legislative districts are voted in.
- Let us choose our legislators. You should not use your power to keep yourselves in power.

Here are three ways you can deliver that kind of message:

- Good: Send email or US mail to the addresses on their official webpages. You can use tinyurl.com/KyLegis as a shortcut to the site that lets you look up your Senator and Representative to find their addresses.
- **Better**: Call 1-800-372-7181 to leave them messages.
- Best of All: Speak to your legislators in person by attending their town halls, forums, and other events or by making an appointment to sit down and talk.

#### Full Description of Request:

The purpose of this request is to make better use of the mostly stagnant Edwards Scholarship Fund. A two-pronged approach is suggested. First, the opportunity will continue for prospective applicants from the Smoketown and Shelby Park areas to request financial assistance to them in their pursuit of higher education following the existing application process. Second, under this proposal, funds will now also be directed to Simmons College in support of students entering the College's soon to be created Education major program.

Starting as early as the Spring semester 2021, MKP will provide a minimum of \$10,000 per year for the next five years in financial assistance to students pursuing a Simmons Education degree. As a point of reference, the full class load of fifteen credit hours requires tuition of \$3300. The scholarships will be offered specifically to students entering Simmons's newest upcoming program - the SCKY Teacher Certification Program. If successful, it would be MKP's intention to maintain this financial assistance beyond the initial five-year period. Additionally, MKP churches and individual church members may be encouraged to join into this financial assistance effort.

Preference should be given, when possible, to students residing in the Smoketown and Shelby Park areas of Louisville as well as members of local Presbyterian churches. Simmons College Admissions Department will identify and select candidates and thereafter provide that student information to MKP upon selection as well as periodic progress reporting.

It is believed this approach to utilizing MKP funds will create a triple benefit in our community over time:

- Financial assistance is provided to disadvantaged black students.
- Financial assistance is provided to Kentucky's only private historically Black college.
- Students graduating from the program will become teachers of color for our community an important benefit for future JCPS students.

#### Simmons College of Kentucky (www.simmonscollegeky.edu)

Simmons College of Kentucky, the only private historically Black college in the state, is a small, urban campus located in the heart of downtown Louisville, Kentucky. Simmons' historic campus, built by formerly enslaved people in 1879, is a campus where history, faith, learning and life come together. Simmons College of Kentucky is accredited by the Association For Biblical Higher Education Commission on Accreditation to grant certificates and degrees at the associate and baccalaureate levels. This agency is recognized by the U.S. Department of Education as requiring the same high academic standards as other national and regional accreditors. Simmons is licensed by the Kentucky Council on Postsecondary Education.

#### Recent News:

- The Gheens Foundation will give Simmons College of Kentucky \$500,000 unrestricted over the course of the next two years. The Louisville-based family foundation has donated over \$3.6 million to the college over the last seven years. (10-9-20)
- Simmons College of Kentucky has a two-year, \$1.3 million grant agreement with the Humana Foundation to bolster Simmons' online education offerings. In part, the grant will fund infrastructure upgrades at the college and help students get computers and Wi-Fi access, according to a news release. (9-16-20)
- Louisville-based hospital system Norton Healthcare Inc. gave \$1.2 million to Simmons College of Kentucky. The grant comes through the Norton Healthcare's James R. Petersdorf Fund and will support education and program initiatives and facility improvements. (9-11-20)
- Cecil "Barney" Barnett and his wife, Gillian Barnett, have pledged \$4 million to Simmons College of Kentucky. Barnett, the founder and chairman of Louisville-based food manufacturer Algood Food Co., was speaking at the inaugural Transform Louisville Education Breakfast Monday. Barnett also is chairman of the Simmons board of trustees. He said \$3 million will go to upgrading three of Simmons College's four buildings, two of which have serious deferred maintenance and one that is not open. (2-11-19)

#### The Simmons Education Program:

The SCKY teacher certification program will prepare teachers at the middle and high school level with the ability to teach sociology, history, English and communications, business, and music. Because Simmons has formed a cooperative arrangement with the Jefferson County Public Schools, Simmons education graduates are assured employment in their chosen profession. Because of Simmons' affiliations with large, diverse networks of state and national church organizations, it is uniquely poised to draw black public-school teacher candidates to Louisville to attend the HBCU.

#### Additional Information:

- JCPS has a mandate form the school board to hire more black teachers. Total black enrollment in the district is 37%; total number for black teachers is 14%. Studies have shown positive outcome is significant for black students who have been exposed to K-12 black educators.
- Simmons is presently vetting candidates for the Program Director Position, as well as the additional instructor positions for the education program.

- Last year, Simmons launched a collaborative pilot teacher Education program with JCPS. They had 130 applicants for the 12 positions available in the cohort.
- Simmons has made a significant funding ask to the James Graham Brown Foundation and are awaiting word on their decision. They have already achieved \$1,750,000 pledged from Brown Forman and YUM to start up the teacher program.
- The goal is for the program to be certified by State Dept of Education by 2025, in time for the first graduating class.

#### Measurable Objectives to be achieved:

- 1. Higher education opportunity provided to disadvantaged local students.
- 2. Provide financial support to Simmons College.
- 3. Increase the number of JCPS Black teachers.

#### **NOTES:**

Finalization of the Education program described above is in final stages of approval and implementation and this proposal is conditional upon further movement. In the event of Simmons not implementing their program, funds can be transferred to Evolve 502.
