Overture to PCUSA General Assembly: The Time is Now to "cherish creation, cut carbon, and speak up"

The Presbytery of XXXX overtures the 225th General Assembly (2022) of the Presbyterian Church (USA) to commit ourselves as a church, a people of faith and a social organization embodying Christian values, to:

- 1) repent of our participation and growing complicity in the processes which havebrought our planetary ecosystem to the tipping point of unsustainability for humans, and mass extinction of other species;
- 2) direct that all PCUSA -financial investments be withdrawn from -industries that contribute to the production of the two major greenhouse gasses, CO2 and methane, accelerating the timeline of the Committee on Mission Responsibility Through Investment (guided by the "Carbon underground 200 and those listed in the Global Industry Classification Standard (GICS) 101010 and 101020"), and effectively end our investment in the production and use of plastics;
- 3) direct the Board of Pensions and the Presbyterian Church (U.S.A.) Foundation to increase investment in low carbon emission renewable energy, energy efficiency, and energy storage in ways that complement policies to transition workers in our present fossil fuel industry into "green" and sustainable energy sector employment;
- 4) encourage all PCUSA members and congregations to study the various documentsproduced by the General Assembly over the past 30 years, including the most recent (2022) Advisory Committee on Social Witness Policy (ACSWP) "Investing in a Green Future: A Vision for a Renewed Creation" document, scripture and other related overtures such as:

- 5) urge our congregations and members to become the needed, faithful change weseek by being carbon neutral, net-zero, or even climate positive by 2030; encourage congregations with historic or landmark buildings to retrofit their structures to the furthest extent possible; implore all PCUSA-related educational institutions (secondary schools, colleges, universities, and seminaries [i]) and individual members to do the same with their homes and facilities;
- 6) advocate through our Office of Public Witness (Washington), UN and otherdenominational offices for national and international accountability around financial obligations and commitments under the United Nations Framework Convention on Climate Change (UNFCCC) and Paris Agreement (https://unfccc.int/sites/default/files/english_paris_agreement.pdf), including the pledges made to assist economically developing and emerging countries* with carbon use mitigation and adaptation;
- 7) advocate through these same channels for climate justice** based in national and and and and and and are commitments to assist economically developing and emerging countries with recovery from the loss and damage resulting from the industrialized countries' disproportionate impact on climate change (aka, "climate debt"), as a new and proactive stewardship of the earth;
- 8) advocate through all PCUSA channels the implementation of the Carbon DividendOverture 08-12, approved by Commissioners in 2018 and encourage our government to pursue other economic strategies for incorporating "externalized" environmental costs into pricing of all goods and services; and
- 9) direct the Presbyterian office at the U.N., Presbyterian Hunger Program staff and ourchurch's Office of Public Witness (Washington office) to develop a 10 year strategy of accompaniment and advocacy before, during and after the annual Conference of the Parties (COP)s to the UNFCCC, utilizing to the extent practicable, our deployed staff and colleagues at World Communion of Reformed Churches (WCRC) and World Council of Churches (WCC). Work cooperatively with former staff and volunteers to the extent possible to provide continuity across the years and in collaboration with voluntary organizations such as Presbyterians for Earth Care to provide updates and make recommendations consistent with our social witness policy.

Rationale:

Presbyterians have pioneered in the recognition of climate challenges and in environmental theology, going back to the 1960's and including major policy statements in 1981 (of both churches, pre-reunion), 1990, and 2008. These statements have drawn on a more faithful reading of scripture.

"The fundamental mandate for creation care comes from Genesis 2:15, where God places Adam in the garden to 'till it and keep it' (NRSV). A better translation from the Hebrew is 'to serve it and to preserve it.' In Genesis 1:26-28, God blesses humankind with dominion over the earth. This acknowledgement that humanity is the most powerful species on earth does not, however, give license to dominate and exploit the planet. Indeed, the following verses affirm the right of animals to share in the bounty of the earth's produce (Gen. 1:29-30). Human 'dominion' as intended in Genesis is best practiced in care for creation, in stewardship, which according to Genesis Noah fulfills best by implementing God's first endangered species act. Moreover, the great creation psalm of the Psalter views humanity as one species among many animal species, all meant to flourish together (Psalm 104:14-23). The psalmist exclaims, 'O Lord, how manifold are your works! In wisdom you have made them all; the earth is full of your creatures' (v. 24). Scripture affirms that God created the world in wisdom and out of love, and it is also out of love for the world that God gave Christ to redeem it (John 3:16). In Christ 'all things hold together' (Colossians 1:17), and 'every creature under heaven' is to receive God's good news (v. 23). According to Revelation, God's work in the world is to 'make all things new' (21:5), to bring about a new creation that does not destroy the old but transforms it, renews it. If the church is the sign of the new creation, then the church must lead the way in caring for creation." - Quote from the 2016

Overture to the 222nd General Assembly on Amending G-1.0304, "The Ministry of Members," by Adding "Caring for God's Creation" that was approved by GA and 104 Presbyteries] contributed by Dr. William P. Brown, William Marcellus McPheeters Professor of Old Testament at Columbia Theological Seminary

As Presbyterians, we aspire to live into these teachings as well as the words of Jesus in the Gospel of Matthew (25:40,45) regarding our call to care for "the least of these" our brothers and sisters, in all their diversity, whose well-being is so intertwined with and dependent upon a healthy ecosystem.

Because of these values we are called to heed the report of the Intergovernmental Panel on Climate Change (IPCC) [ii] This research organization has issued six "assessment" reports over the last 33 years since its founding in 1988 focusing on the interaction of human activity and our world's warming atmosphere and changing climate. Their most recent report since 2015, issued in August of 2021, was compiled and agreed to by 234 authors from 65 countries. It states that "it is unequivocal that human influence has warmed the atmosphere, ocean and land."

This "human influence" is, to a preponderant extent, due to the use of fossil fuels by the industrialized countries during the last 50+ years. In this period, "greenhouse" gas emissions have increased to their highest levels in over 2 million years, increasing global average surface temperatures almost 1.2 degrees Celsius over pre-industrial levels. Global surface temperature has increased faster since 1970 than in any other 50-year period over at least the last 2000 years and global surface temperature is the highest in over 100,000 years. Optimistically, we are looking at a current trajectory of around a 1.8 degree increase by 2050, no matter how quickly we act[iii].

Sea level has risen faster since 1900 than over any preceding century in at least the last 3000 years and will be irreversible for millennia to come. Acidification of the oceans due to absorption of carbon dioxide over the last 50 years is unprecedented in at least 2 million years. It is virtually certain that hot extremes (including heatwaves) have become more frequent and more intense since the 1950s, while cold extremes (including cold waves) have become less frequent and less severe. These climatic changes have already caused super-sized floods, droughts, fires, hurricanes/cyclones, species loss and other effects across the U.S. and globe. Climate and agricultural zones have shifted poleward and all seasons are growing hotter. Humans are already driving the sixth mass extinction event, destroying ecosystems upon which we depend and eliminating countless species from the planet forever.

The global Paris Agreement goal is to keep global warming 'well below 2°C', and pursue efforts to limit it to 1.5°C. To avoid going beyond 1.5°C, global emissions need to reach their peak immediately and then fall within the next decades – reaching net zero by the middle of the century at the latest. That means we need to start acting on climate change now. We must redirect our energy production and economic activities sufficiently to avoid pushing our planet beyond the point at which it will be able to sustain life as we know it, triggering catastrophic death and destruction. To do so, the world needs to halve its current emissions by 2030 and reduce emissions to net zero by 2050; a challenge that can only be met if emissions reductions start now. The IPCC report has conclusively determined that humanity must act within ten years. This does not mean

we can wait a decade before acting. Every year we delay dramatically increases the cost of transforming our energy system. The time to act is now!

Furthermore, while less-developed nations and indigenous peoples are the least responsible for creating these consequences, they are also the most endangered and least well equipped to respond to them. Efforts should be made to prevent a new "green" colonialism by seeking ways to include communities in developing nations and other indigenous groups in benefitting from green technologies rather than exploiting them for their resources.

Given their geographic as well as socio-economic positioning and lived experience, these most vulnerable among the earth's populations possess unique perspectives regarding how to care for our common heritage of ecosystem, soil, species diversity, air and water, yet they are frequently excluded from the decision-making processes regarding the changes needed to protect them. The challenges facing our planet can seem overwhelming. As Christians we are inspired to act not out of fear, but out of love for God, love for our neighbors (near and far, present and future), and love for God's creation entrusted to our care.

Among the options before us for how best to show our love for our neighbors and the planet is extending "the polluter pays" principle, (embodied in the 1992 Rio Declaration) beyond prohibitions to incorporate "costs" to the global ecosystem into the pricing of goods and services. This will, however, entail significant shifts in our economy and behavior. One powerful economic tool that can help achieve these shifts and behavior changes, and has strong support among economists, business leaders, scientists, a number of faith communities, and people on multiple sides of the political spectrum, is putting a price on carbon that more faithfully reflects the full environmental cost of using fossil fuels. The 223rd General Assembly

(2018) affirmed this approach when it passed [08-12] "On Supporting Carbon Pricing." Supporting this tool through education and advocacy furthers needed systemic economic change, previously approved General Assembly policy, and creation care[iv].

Another of the ways many people of faith are promoting a reduction in climate changing greenhouse gasses is by calling on their congregations and denominations to disentangle their investments from the fossil fuel industry. As of today, according to Richard Brooks, Director of the Climate Finance Network Stand.Earth, 1,497 institutions including 520 faith groups/organizations, (among them, our fellow Presbyterians in the Church of Scotland and the Presbyterian Church of Ireland), are in the process of divesting a total of \$39.88 trillion from fossil fuel-related investments. This is larger than the annual GDP of the U.S. and China combined. Europe's largest pension fund in the Netherlands has announced a decision to divest within the next year and a half. (See presentations by Brooks, the Church of Sweden's Financial officer and a number of other church leaders on divestment as part of COP26 in 2021 at: Faith Webinar: COP26, Fossil Fuel Divestment and a Just Transition for All - YouTube

We wholeheartedly agree with Bishop Hugh Nelson of the Church of England who so aptly put it in his address to the COP 26 (2021 meeting in Glasgow, Scotland) in the webinar linked above, that we are called to "cherish creation, cut carbon and speak up."

*Terminology varies as to how best to differentiate those countries and communities that are the greatest producers of greenhouse gasses from those that contribute very little; between those that are better positioned due to political power, geography and wealth to withstand the consequences of climate change and those that are not. We have chosen to follow the United Nations' terms of "Developing Countries, Emerging Economies and Industrialized Economies" as aligning generally with "least polluting, more polluting and historically most polluting" countries and to assume that the historically most polluting countries hold greater political as well as financial power to determine their own destiny and provide support for adaptation to, mitigation of and recovery from the devastating effects of climate change upon their own people. In shorthand, these nations are often called "global north"/"global south." Marianna Liete of the ACT Alliance of church based organizations lifts up the seminal writings of Boaventura de Sousa Santos (

Boaventura de Sousa Santos - Book chapters) for his discussion of these terms.)

**"Climate justice is a concept that addresses the ethical dimensions of climate change. Applied ethics, research and activism using the term approach anthropogenic climate change as an ethical, legal and political issue, rather than one that is purely environmental or physical in nature. This is done by relating the causes and effects of climate change to concepts of justice, particularly environmental justice and social justice. Climate justice examines concepts such as equality, human rights, collective rights, and the historical responsibilities for climate change." Wikipedia

PROPOSED Conflict of Interest Policy and Matrix February 26, 2022 Conflict of Interest Workgroup

Our Presbyterian polity is built on a foundation of underlying trust. Our Book of Order states:

G-1.0102 The Fellowship of the Congregation

The polity of the Presbyterian Church (U.S.A.) presupposes the fellowship of women, men, and children united in covenant relationship with one another and with God through Jesus Christ. The organization rests on the fellowship and is not designed to work without trust and love.

Individuals elected by the Presbytery to serve on the committees, commissions or other elected entities of the presbytery are members of congregations within the presbytery's bounds. Presbytery staff are appointed to serve as resource persons for the commission. For purposes of this policy, elected members and appointed staff resource persons are referred to collectively as "members." In their election or appointment, the presbytery affirms its expectation and trust that each member will follow their conscience and act in accordance with scripture, the Book of Order, and their best discernment of the guidance of the Holy Spirit. It is understood that issues may arise in deliberations that grow from an individual minister of the Word and Sacrament commission member's ministry, from within the congregation where a commission member ruling elder holds membership, or where a member minister of the Word and Sacrament not holding an installed position in a local congregation may be affiliated.

Standards of Ethical Conduct for Mid-Kentucky Presbytery instruct all persons called to ministry within Mid-Kentucky Presbytery "to conduct all matters so that . . . conflict of interest and exploitation are avoided." (Presbytery of Mid-Kentucky Standards of Ethical Conduct, paragraph 2c.)

A conflict of interest exists when a person in a decision-making process has an interest, direct or indirect, that could reasonably be expected to compromise their judgment, decisions, or actions. Any concern regarding a conflict of interest may be directed to the moderator of the group to which they are involved or to the presbytery stated clerk.

Conflicts of interest within deliberations are inevitable. The matrix that follows provides a policy for elected and appointed leaders and members when determining whether it is appropriate for a particular member of the group to participate in its deliberations. This matrix is not intended to be all-inclusive but addresses common scenarios in group deliberations. Nothing in this matrix precludes a group member from seeking the group's guidance and assistance regarding difficulties and challenges within their own congregation or call. The presbytery commission, committee or other group may, at its discretion invite its members affiliated with congregations under discussion to participate in conversation, without vote, when their input is deemed important to the group's deliberations. Any member may absent themselves from discussion and from vote on any issue wherein they believe a conflict of interest exists for themselves or for a member of their family.

All members have equal vote in group decisions.

The Five Questions – submitted by Wm. F. Owens

1. What events or persons have significantly affected your ministry?

During High School, following my "born again" experience (as mentioned in my "spiritual journey"), the Associate Pastor of my home church, the Reverend Pete Carruthers, took me under his wing and became my mentor. He met me where I was, gave practical encouragement to my faith development, and helped me grow in self-confidence and leadership skills. He introduced me to the writings of Dietrich Bonhoeffer, beginning with *Ethics*. I was both fascinated and inspired by Bonhoeffer's work, and through the years I grew an extensive library of Bonhoeffer books (or books about Bonhoeffer's life and theology). *Ethics* opened my eyes to see that the will of God may lie beneath a number of possibilities, that is, God's will was not the proverbial single needle in the haystack. This gave me freedom (to borrow from Bonhoeffer) to "make up my mind and enter into the tempest of living." Pete presented me with opportunities to assist in leading worship, and later, during college, to provide leadership as a summertime youth worker. He helped me to recognize God's grace operative in my life. His love of life and passion for mission grew on me. When he was diagnosed with cancer, he faced his prognosis with dignity and used that experience to educate about death and dying, and about care-giving. Looking back, I see Pete's life and work as having planted the seeds of my interest in pastoral care, mission, and hospice ministry.

2. What theological beliefs have emerged as critical to your practice of ministry?

While leadership in the church is shared between Teaching Elders and Ruling Elders, all of God's people are ministers. We are called by a covenanting God who is ever-faithful, ever-loving and ever-present. Individually and corporately, we are called to partner with God whose in-working results in our out-working. God calls us to move beyond ourselves and the walls of our churches to love our neighbors in the world God created. We are called to a faithful stewardship that seeks proper use of the gifts of God's creation. Especially in hospice ministry, I have come to stand on the full assurance that God comforts us in all our troubles, so that we can comfort those in any trouble with the comfort we ourselves have received from God. (2 Cor. 1:3-8).

3. What experiences have challenged or affirmed your faith?

COVID-19 has definitely challenged the *practice of ministry* (with adaption to virtual worship and the many uses of Zoom, etc.) and these times and new practices have surfaced vital questions, such as, "Who is Jesus Christ for us, today?" and "How are we to be the Church in this time?" In my most recent church position, I experienced behaviors and attitudes of church leaders and members that have made me question my call to ministry. I think we've been given the opportunity to think if not move outside the box, hopefully to find the "magic" that happens outside of our comfort zones.

4. What is your view of the sacraments in light of your practice of ministry?

Rich in meaning, the Sacraments of Baptism and the Lord's Supper serve as signs and seals of our incorporation into the Body of Jesus Christ, and of our communion with the crucified and risen Lord. They are gracious acts of God, by which Jesus offers his life to us in the power of the Holy Spirit. They are also our acts of gratitude, by which we offer our lives to God in love and service.

5. What is your view of the government of the Presbyterian Church (USA) in light of your practice of ministry?

Our form of government and Reformed theology go hand in hand. At the core of our identity is a secure hope in the grace of God in Jesus Christ, a hope that, by the power of the Holy Spirit,

empowers us to live in gratitude. It is our gratitude for God's grace that moves us to join in God's mission in the world, with ministries of love and justice, reconciliation and peace. I like that the leadership of the church is shared between Teaching Elders and Ruling Elders, and women may be ordained into leadership positions. I am proud to be a Presbyterian and oftentimes I lift before the congregations being served the work of the presbytery and denomination.

Spiritual Journey

When my Baptist father and Methodist mother married and began raising their family of five children, they joined a Presbyterian church. I had no choice; I followed suit. Hook, line, and sinker. In this church, I was baptized as an infant and confirmed in the sixth grade, and in between: attended kindergarten, sang in the children's and youth choirs, attended church camps, and was active in youth fellowship and Boy Scouts. Later, I worked one college summer to help with the youth ministry, which brought me, interestingly, to eastern Kentucky for a first-ever mission trip.

Going through confirmation as a sixth grader, I embraced the faith into which I had been baptized. So I thought. Admittedly, I was going through the motions of what others expected of me. When I started high school, I entered a dark period (of less activity in the church, and hanging with a wrong crowd and becoming involved with alcohol, drugs, and shoplifting). I knew in my mind and heart that I was not living rightly. With college on the horizon and seeking to turn my life around, I prayed an earnest, simple prayer, "God help me." And God did just that! It was a true conversion which I have dubbed my "born again" experience. This is when I truly began to embrace the faith I had been baptized into. Seeing the change in my life, friends and teachers began encouraging me to enter the ministry. And so I began to explore that possibility.

Long story short, during my senior year of college, while making application for seminary, I came to the conclusion that while others could envision me in the ministry, I could not own that for myself. So, seminary was put off ... for eleven years. During this time, I had a mix of work experiences: school teacher, youth director (in a Methodist church), college admissions recruiter, crisis counselor for runaway youth and their families, and as a director of youth and young couples in my home church.

After an associate pastor for youth had vacated his position at my home church, the senior pastor called me to fill the void. After two years in this position, I was able to "see" myself as a Minister of Word and Sacrament. I owned the calling to enter the ministry as genuine, and again embraced the faith in which I had been baptized. I made application and was accepted into Columbia Theological Seminary, and upon graduation was ordained and installed as an associate pastor. In the years since, I have accepted calls to serve as co-pastor, pastor, and interim pastor, and worked in the national office of the PC(USA). Thus, I have enjoyed a rich, varied work experience in the church.

Along the way, I pursued clinical pastoral education (CPE) as a feather in my cap to better pursue pastoral ministry opportunities in the church. Little did I know that it would lead to hospice chaplaincy. Among its many learnings, hospice ministry was a call to "check" my theology, to

have my theology be large enough to accommodate the theologies and religious preferences of the diverse population of patients and their families we served.

Over the years, since seminary, I've kept up with three friends with whom I graduated. We meet annually for one week and structure our time together using a model we learned from having participated in a Lilly Fund program administered by Columbia Seminary: S³, for study, service, and Sabbath.

The journey of faith upon which I embarked – initiated by my loving parents – is a lifelong process. God is not through with me yet. Thankful for God's continual presence and grace, I continue to embrace the faith in which I was baptized in new and different ways.



Commission on Preparation for Ministry Report to Presbytery – February 2022

Items for information:

- The CPM continues in a relationship of care with four inquirers and seven candidates, two of whom are certified ready to receive a call. Three are currently in seminary, five are working post-seminary, and two are in PhD programs.
- The CPM revisited our requirement that all candidates in our presbytery complete one unit of clinical pastoral education (CPE). We have experienced more inquirers and candidates juggling full- or part-time work with seminary, or who are still working through the candidacy process after graduating from seminary. After discussing the challenges that this requirement can present and considering the benefits of this particular kind of educational experience, the CPM decided to uphold our CPE requirement. We will consider alternative ways to fulfill this requirement as requested on a case-by-case basis should CPE present a hardship to a candidate.
- In coordination with the CPM, John Odom and Doodle Harris have continued working with Presbyterian students at Louisville Seminary, providing opportunities for fellowship, conversation, encouragement, and guidance.
